Overnight Parking

Reminder: Parking on Village streets is prohibited from 2:00 AM to 6:00 AM all year long. Temporary parking permits are available from the Village Office for special circumstances for the months of April through November. The permits allow for the parking of vehicles in front of your own property for a limited amount of time at the discretion of the Village Clerk. Please avoid getting a summons by not leaving any vehicles on the street overnight without a valid permit issued by the Village.

2010 Census

The next decennial census is approaching. The U.S. Constitution mandates a headcount of everyone residing in the United States. This count is done every ten years. The first Census was conducted in 1790 and has been carried out every ten years since then. Why should you fill out the census form?

- It's important. Census data affects funding for your community, your community's representation in Congress and your community leader's planning decisions.
- It's easy. The census questionnaire takes only a few minutes to answer and return by mail.
- It's confidential. Your responses are protected by law (Title 13, U.S. Code, Section 9). All Census Bureau employees have taken an oath to protect confidentiality and are subject to a jail term, a fine – or both – for disclosing any information that could identify а respondent or household.
- It's required by law. The information you provide is combined with responses provided by your neighbors and other households across the country, to provide summary statistical data that are used by various local, state and federal agencies.

County Road Paving

You have probably seen the many roads in and around the Village that have been paved in the last few weeks. Most of the paving activity has been done by the Rockland County Highway Department, on County roads (Grandview Avenue and Limekiln Road). Many people are confused about the paving process that was used. It was a two step process that is less expensive than the standard asphalt process, but should last just as long. The first step was something called hot-in-place. In that step, large trucks melted down the old road surface and basically recycled the existing material. While it may have looked finished at that point, that process by itself would not last as long as necessary without a sealer step. In this case, the County used the tar-and-chip method to provide the sealer coat. In this step, hot tar was poured on the road, and covered with gravel that was then rolled into the surface. After some settling time, sweeper trucks came back to clean up most of the loose left over gravel. While this is an extremely cost effective and durable surface, it is also very unpopular. The loose gravel is hard to walk on, and especially dangerous for bicycles, scooters and motorcycles. In addition, cars and trucks can kick up the gravel when they drive over it. Fortunately, these issues do not last very long, and although inconvenient for a time, it's the price we have to pay to have newly paved roads. The tar-and-chip method was used on McNamara and Spook Rock Roads not too long ago, and most people would not even be able to tell anymore. To date, the Village has not used this process on any of our roads, but that could change due to budget concerns. We are currently looking into several possible alternatives for future paving projects. For now, we used standard asphalt paving for the East Willow Tree Road paving project.

Neighborhood Gatherings

Just over six months ago the Village passed its new neighborhood gatherings law. This law was passed to provide for the wants of many Village residents while at the same time ensuring the health and safety of all residents of the Village. The last provision in that law stated that violations would not be issued until six months after the law was passed. This was done to allow existing gatherings time to prepare and apply for the required permits. Some groups have already applied and are well along their way. Others have not yet If you are associated with a applied. gathering that requires a permit, please contact the Village Building Department as soon as possible to get the process started. If you are unsure if your group requires a permit, the Village can provide information to help you determine what is needed.
