Mayor's Reports

Streetlights-Timber Trail

Mayor Katz stated that the last few meetings the Village Board has discussed streetlights on Timber Trail. Mayor Katz stated that Ms. Ivey was absent and he would like her decision in reference to the streetlights.

Ruth Ivey stated that she is not in favor of the installation of streetlights on Timber Trail.

Mayor Katz thanked the Board and the residents of Timber Trail for having an honest and open discussion. Mayor Katz stated that he will notify the residents via email of the Board's decision to not install streetlights.

Suez & Paving

Mayor Katz stated that he attended a meeting with representatives of Suez and the meeting was nonproductive. The Mayor has reached back to Mr. Madden to have a more productive meeting with him as he is authorized to make decisions on behalf of Suez. Board Members expressed that the Village needs to take whatever steps necessary to recoup the funds that the Village spent based on Suez's error.

419 Route 306

Mayor Katz stated that the Village has received one proposal for the work and as per the Village Engineer, we are waiting for two more. Mayor Katz stated that he hopes to have those proposals for discussion at the 12/17/19 meeting.

Route 306 Speed Reduction

Mayor Katz stated that he has received a request from a resident on Lime Kiln Court to reduce the speed limit on Route 306 from Lime Kiln Road to Pomona Road from 45 mph to 35 mph.

Board Members are in favor of the speed reduction.

Mayor Katz stated that he will reach out to Zebrowski, Carlucci and Brabenec for support and have the board pass a resolution to give to the NYS DOT for the Board's January meeting.

RCSWMA Garbage Contract

Mayor Katz stated that the Authority has stated that they are close to having a contract with Donato Marangi for garbage service for the Village. Mayor Katz has stated that the Authority has agreed accept a payment from the Village of the remaining garbage funds the Village collected and the Authority will in turn lower the tax bill for this January to reflect the receipt of these funds. Mayor Katz stated that he has already drafted a letter to the residents and is seeking comments by the Board and RCSWMA by Friday.

Treasurer's Report

Ms. Berard, Village Clerk, Mayor and Board Members discussed the escrow accounts and the applicants that are in the negative. It was suggested that the fee schedule be amended to include mandatory deposits for PB and ZBA applicants along with computer restrictions for nonpayment.

Village Clerk's Report

Village Clerk stated the Village Attorney has been working with the Village Engineer in reference to property access for the repair to the stream at 419 Route 306. 26 complaints submitted to the Village for action. The Village is waiting on a proposal for interior painting of Village Hall. Ms. Berard and the Village Clerk have been trained for the NYS Retirement new online system. The Village received a loyalty check from Comp Alliance in the amount of \$500.00.

Howard Richman stated that on Kentor the small plow truck does not come around any longer and clean out his neighbor's driveway. Mayor Katz requested that Mr. Richman place the request in writing, and he will discuss with the Highway Superintendent.
