Community Solar

Mayor Katz stated that Good Energy, the Village's Administrator has provided the Village with the option of a Community Solar program. The program will give residents an approximately 10% reduction in electric costs and also provide the Village with \$50.00 for each home that signs up. The Mayor presented a draft Memorandum of Understanding between Nexamp and the Village. Board Members are in favor of the program; however, they have some questions in reference to the level of commitment from homeowners. Ben Selig, Village Attorney stated that he has some concerns regarding the Village indemnifying Nexamp as stated in the Memorandum of Understanding. Mayor Katz stated that he will speak with Good Energy and address the Board's concerns and report back.

Village Clerk's Report

Village Clerk stated that the Village received 30 complaints this month. The following projects are being worked on; election preparation, NYS Building Annual Reporting, Electrical work quotes for Village Hall, Village Park walking paths quotes, NYS Retirement training, updated all Village forms, and scheduling construction work at 419 Route 306.
