NOW THEREFORE BE IT RESOLVED, that it is determined that the proposed Local Law will not have a significant effect on the environment as defined in the New York State Environmental Quality Review Act for the reason that said proposed Local Law would afford property owners in residential districts the ability to provide for greater privacy where a fence is set back at least 2/3 of the appetible minimum setback provision, and

BE IT FURTHER RESOLVED, that in accordance with the provisions of Section 230-176 of the Village of Wesley Hills, such Local Law is hereby referred for review and report to the Planning Board, Zoning Board of Appeals, Village Attorney, Village Engineer, Building Inspector, Code Inspector of the Village of Wesley Hills, The County of Rockland Planning Department, and all abutting municipalities, and

BE IT FURTHER RESOLVED that the Village Clerk is hereby directed to forward a copy of such propose Local Law to such Board s and officials forthwith.

Tent Application & Procedure

Mayor Katz stated that the Fire Inspector is concerned with the length of time for the tent permit which is being proposed at 30 days. He is suggesting 10 days.

Marion Ben-Jacob stated that there needs to be an exception for the shuls which are currently using tents for worshipping purposes due to COVID-19.

Board Members agreed and stated that they feel that the wording that they placed in the application/procedures that states that the time frame is subject to the discretion of the Village will cover the shuls and also place them on notice that we are coming to reinspect. Board Members are in favor of changing the time frame to 10 days.
