Item #2 Resolution #132-20 Resolution releasing escrow funds with respect to 4 Soundview Drive

Marion Ben-Jacob made a motion to approve the following resolution, seconded by Howard Richman:

WHEREAS, pursuant to an Escrow Agreement between the Village of Wesley Hills and Rifki Eichorn dated October 4, 2018, the said Rifki Eichorn deposited with the Village of Wesley Hills an escrow deposit in the sum of \$1,500.00 in order to guarantee that certain conditions set forth in the letter of the Village Engineer of the Village of Wesley Hills dated September 14, 2018 were completed; and

Discussion

Mayor Katz stated that this contract is to set the Village's electricity accounts as commercial accounts and lock in a fixed lower commercial rate. Mayor Katz stated that he saw the County of Rockland's announcement and contacted them for the Village to join.

Upon vote, this motion carried unanimously.

Treasurer's Report

Donalee Berard presented the monthly financial reports and stated that the Village is six months into the year, and we are on target. There are a few lines that we need to keep an eye on and should be reviewed. Ms. Berard stated that later this month she will do her first run on the draft budget.

Mayor's Report

Orange & Rockland Meeting

Mayor Katz stated that he attended a conference call today with Ruth, Ed and 11 of O&R team members to discuss the Village's memo on O&R's handling of Tropical Storm Isaias. Mayor Katz stated that O&R was apologetic and offered several reasonings for the way things worked out. Mayor Katz stated that O& R is making enhancements to their system and contracted for an additional 100 buckets trucks.

Ruth Ivey stated that she felt that the meeting could have been more productive and feels that the Village should investigate having a substation in the Village. Ms. Ivey stated that she looks forward to the meeting with the Mayor and the Village's O&R representative.

Mayor Katz stated that in January O&R will send their vegetation representative to the Village to discuss their process.

Ed McPherson stated that the meeting was eye opening on O&R's processes and the \$1 million in enhancements to the system with the new switches O&R is making. Mr. McPherson stated that he was pleased that O&R explained the main electric feeds into the Village.
