		c) In addition to the re-inspection fees as set forth in items 14a) & 14b) above, all applicants and property owners will be required to pay to the Village of Wesley Hills all fees of the Village Engineer and Village Planner as deemed necessary in connection with any inspection required by the Village Building Inspector, the Village of Wesley Hills Zoning Board of Appeals, the Village of Wesley Hills Planning Board and the Village of Wesley Hills Board of Trustees.
