Chairman Weinberger called the meeting to order at 8:05 p.m.

Item #3- Ephraim Jacobson-Public Hearing 5 Jodi Court

Chairman Weinberger read into the record the following public hearing notice:

Public Hearing to consider the application submitted by Ephraim Jacobson for variances from the provisions of Section 230-17 the Table of Dimensional Requirements of the Code of the Village of Wesley Hills, to permit the construction, maintenance and use of an addition to a single family residence having a front yard of 42.2 feet at Amsterdam Ave instead of the minimum required of 50 feet and rear yard of 39.7 instead of the minimum required of 50 feet.

The subject premises are situated on the southeast corner of Amsterdam Ave and Jodi Court, known as 5 Jodi Court, designated on the Tax Map as Section 41.11 Block 1 Lot 50, in an R-35 Zoning District.

Todd Rosenblum was present on behalf of the Applicant was affirmed to tell the truth. Mr. Rosenblum stated that the Jacobson's wish to expand their home by adding a second floor to an existing ranch style home. They would also like to add a small addition to the left side, front and back along with two decks on the home. The following variances are being requested:

Rear yard	50	39.7

Mr. Rosenblum stated that the rear variance is need for the deck and not for the old or new structure. Mr. Rosenblum stated that the existing home is situated on the 45° angle and it is a corner lot. There is an existing pool to remain which the Applicant needed to work around. Mr. Rosenblum added that the home across the street received very similar variances due to the position of their home.
